In order to break the transmission chain of contagion of COVID-19, undersigned has issued prohibitory orders under section 144 of the Code of Criminal Procedure, 1973 vide endst. No. 5713-99 dated 23-3-2020 vide which restrictions on movement of any person outdoor (curfew) from 23-3-2020 (2.00 PM) till further orders.

- 9. All doctors / employees of Health Department posted in the district for duty purpose
- 10. All the Veterinary Doctors for duty purpose and Veterinary Hospitals
- 11. AIIMS, Bathinda
- 12. Bottling Plant BCL, Machana for the purpose of manufacturing of Sanitizer.

These institutions/ officers/ employees will follow the instructions / orders issued by Govt. of India/ Govt. of Punjab and undersigned regarding the Covid-19. Any violation of these instructions / orders is liable to criminal prosecution.
