**NOTIFICATION**

The 21st April, 2020

**No. G.S.R. 24/Const./Art.309/Amd.(1)/2020.-** In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to make the following rules further to amend the Punjab Animal Husbandry (Group-A) Service, Rules, 2014, namely:-

**RULES**

- 1 (1) These rules may be called the Punjab Animal Husbandry (Group-A) (First amendment) Service Rules, 2020.
- (2) They shall come into force on and with effect from the date of their publication in the Official Gazette.
2. In the Punjab Animal Husbandry (Group-A) Service, Rules, 2014, in Appendix-B,
  - (i) against serial No.1, under the column captioned as "Promotion", for the existing entries, the following shall be substituted, namely:-

"From amongst the Joint Directors, who have an experience of working as such for a minimum period of two years:

Provided that in case a Joint Director having two years experience of working as such is not available, then from amongst such other members of the Service, who have got atleast twenty-eight years of regular service, including the service rendered as Joint Director/Deputy Director/Assistant Director/Senior Veterinary Officer/Veterinary Officer, taken together, and who have successfully completed the probation period as required.";

- (ii) against serial No.2, under the column captioned as “Promotion”, for the existing entries, the following shall be substituted, namely:-

“From amongst the Deputy Directors, who have an experience of working as such for a minimum period of two years:

Provided that in case a Deputy Director having two years experience of working as such is not available, then from amongst such other members of the Service, who have got atleast twenty-six years of regular service, including the service rendered as Deputy Director/Assistant Director/Senior Veterinary Officer/Research Officer/Veterinary Officer, taken together, and who have successfully completed the probation period as required.”; and

- (iii) against serial No.3, under the column captioned as “Promotion”, for the existing entries, the following shall be substituted, namely:-

“From amongst the Assistant Directors/Senior Veterinary Officers/Assistant Research Officers, who have an experience of working as such for a minimum period of four years:

Provided that in case an Assistant Director/Senior Veterinary Officer/Assistant Research Officer having four years experience of working as such is not available, then from amongst such other members of the Service, who have got atleast twenty-four years of regular service, including the service rendered as Assistant Director/Senior Veterinary Officer/Assistant Research Officer/Veterinary Officer, taken together, and who have successfully completed the probation period as required.”.
