7 Background of the scheme and its objective

In Punjab Large number of the total population is of the scheduled castes whose main occupation is animal rearing besides working as landless labourers. Therefore, their main stake to earn their livelihood is on these animals which, include buffaloes and cows. The economic status of these people is such that they are unable to provide balanced compounded feed and basic health care facility such as periodical deworming etc. Resultantly, they are not in a position to fully exploit the genetic potential of these animals. In the absence of proper care of milch animals, they cannot get full benefits (income etc.) form these animals and the initial maturity of these animals get delayed, inter calving period increases and the net lactation yield remains low. These draw backs cause financial losses to the farmers /livestock breeders due to high mortality of animals.

Earlier the scheduled caste families used to take female calves/heifers/adult animals on contract basis from the rich farmers in the village and used to raise them up to calving stage. After calving the cost of the animals was determined at the market price and the option was open for them either to purchase the animals by paying 50% of market price agreed to or get the contract amount.

If the scheduled caste families, who has been doing such job earlier are provided with younger female calves, for rearing on a scientific way, the profit will be tremendous and it will benefit the scheduled caste families in uplifting them from poverty line. Animals so calved can be sold in the market or can be kept for milk production. The calves under this scheme will be selected from dairy farms around the cities, where buffaloes of superior genetic potential are available in abundance as the aim of these dairy farmers is to procure more milk from animals only not to rear calves.

When these calves which are purchased form high yielding dams come to milking stage they will be producing milk to the tunes of 15.00 kg per day or more at the first calving and the average milk yield of such animals will be 3000 kg to 3500 kg per lactation . The poorest among the poor will not only get out from the poverty zone but they will also have better living conditions.

8. <u>Manner in which the scheme is proposed to achieve these objectives:</u>

The objective of this scheme is to improve the economic status of the BPL Scheduled Caste, landless labourers involved in the Animal Husbandry practices by providing financial assistance to them for rearing of one Buffalo calf of age upto 1 year. When this calf will fully developed, the beneficiaries can sell it in the market or can keep the same for milk production. This would help them to generate additional family income to cross the poverty line. The calf under the scheme will be selected by the beneficiary with the assistance of Animal Husbandry Department from the dairy farms around the city where buffaloes of superior genetic potential are available in abundance and the aim of dairy farmers is to procure more milk from animals only.

With these objectives in mind, the department of Animal Husbandry, Punjab has prepared a scheme to help the scheduled caste families. Under this scheme, each beneficiary will be paid Rs.10,000 for purchasing of one buffalo calf upto 1 year of age as 100% subsidy. Deworming and vaccination haiferof the animals will be done by the Animal Husbandry Department free of cost. This calf will be selected by the beneficiary with the assistance of departmental committee comprising of Vety. Officer, Senior Vety. Officer of the area and representative of the Deputy Director Animal Husbandry of the concerned District.

The beneficiaries will have to construct a shed managed by himself, other necessary items, i.e. cattle feed, green fodder, dry fodder, mineral mixture, ropes, chains and buckets etc. will have to be provided by the **beneficiaryes** from his own pocket and have to do the necessary job for the upkeep of the animal.

9 Progress made to date

No amount was released during 2016-17, so no expenditure has been incurred under this scheme. During 2017-18 State Govt. Approved this scheme for Rs. 51.00 lac .

This Scheme will be implement in the state by Animal Husbandry Department. The Deputy Direvtors Animal Husbandry punjab (District level) would be the DDO's of the Scheme. The amount would be tranfered to bank account of the beneficiary through RTGS so that Direct Benefit Tranfer could be promoted.

7. Background and objective of the Scheme.

Goat breeding has been adopted traditionally by some scheduled caste families in the State. Most of these scheduled caste families do not have land. Goat rearing requires very less space and limited investment besides returns are big. These scheduled caste families are well conversant with their management. Goat population in Punjab is mostly maintained by scheduled caste families. Due to poor economic conditions and lack of funds and other compelling demands of the animals, the scheduled caste families are unable to rear goat on scientific lines and are unable to provide required inputs for proper exploitation of genetic potential of the goats reared by them. If these goats are reared on scientific lines with proper health cover, the economic returns can be optimized which will help in improving the economic status of scheduled castes families in the state.

8. <u>Manner in which the scheme is proposed to achieve the objectives:</u>

The Department of Animal Husbandry has prepared a scheme to help the scheduled caste family to maintain 3 goat kids. These goat kids will be made available at @10000/- per unit of cost. Beneficiaries shall construct the house for these goat kids form his own sources. The beneficiary will maintain health cover facilities and good enviornment for goat kids by their own sources by visting nearest veterinary institution regularly. The proposed envisage is to help rearing of goat kids by providing financial assistance for purchase of goat kids. The approximate cost will be of Rs. 3333/- per goat kid at the age of 4-6 months. It is proposed to setup 500 such units of 3 goat kids each.

The department of Animal Husbandry is having a Network of Veterinary hospitals/dispensaries. The beneficiaries can be identified by the local Veterinary officer. These goat kids will be selected by the beneficiary with the assistance of departmental committee comprising of Vety. Officer, Senior Vety. Officer of the area and representative of the Deputy Director Animal Husbandry of the concerned District. These goats will be propagated by the beneficiary for future benefits of is own.

No amount was released during 2016-17, so no expenditure has been incurred under this scheme. During 2017-18 State Govt. Approved this scheme for Rs. 50.00 lac

6. Background and objective of the scheme:-

Poultry sector provides nutritional security, employment Generation & subsidiary income especially to the rural poor. However, there is increasing demand of egg & meat. Turkey Farming can contribute significantly towards improving the qualitay intake of meat and meat products. To exploit this opportunity Animal Husbandry department Punjab purposed to take up turkey farming in the state. Later on with the experiences they can set up turkey farming at large scale & this scheme will popularize commercial turkey farming in the area in which production is possible.

7. Manners in which the scheme is proposed to achieve the objective:

The Animal Husbandry Deptt. Punjab with the objective of helping the scheduled caste families has proposed the scheme, as under 500 BPL scheduled caste families will be selected from the proposed areas.

- i) Each family will be provided sum of Rs. 4000/- for the construction of Turkey night shelters (Khuda) (7'x7') & for the purchase of utensils to rear 12 poults to be supplied by the Deptt. Officials. The shelter is required to protect the poults /Turkeys from severe hot, cold climatic conditions & from the attack of predators.
- ii) Each family (unit) will be provided with 12 turkey poults of 6-8 weeks unsexed to the beneficiaries by the Animal Husbandry Deptt. Punjab from Govt. Poultry Farm, Malerkotla. The cost of procuring, rearing and transportation of these poults will be born by the Deptt. and the cost of each unit would be around Rs.4000/-
- iii) The beneficiary will rear them and market/breed them according to their needs.
- 8) **Progress made to date**:- No amount was released during 2016-17, so no expenditure has been incurred under this scheme. During 2017-18 State Govt. Approved this scheme for Rs. 40.00 lac.
- 9) **Staff created under the scheme**:- No new staff to be created, the scheme will be implemented through the existing staff.
- 10) **Programme for the year 2017-18**:- About 6000 unsexed poults will be supplied to 500 BPLscheduled caste families in the state from Govt. Poultry Farm, Malerkotla.
- 12) Additional staff required for the scheme:- No new/ additional staff is proposed to be created.

7. Background and objective of the Scheme.

The landless and marginal below poverty line Scheduled Caste families would be provided a hand driven chaff cutter at their door step so that they can feed their animals properly and easily.

The landless agriculture laboures and marginal SC farmers who keep with them milch animals and other livestock for their domestic need collect the green fodder from the fields but have no fodder cutter of their own. Under this scheme subsidy would be provided to 500 BPL/SC Families for good quality hand driven chaff cutter at a cost of Rs. 8000/- each. Under this Scheme 500 families would be covered.

8. Manner in which the scheme is proposed to achieve these objectives

The Department of Animal Husbandry has a vast network of Veterinary Hospitals and dispensaries, which are spread throughout the state. This scheme would be implemented through the exisiting field Staff of the department. Under this scheme beneficiaries would be selected by the concerned veterinary officer, S.V,O. and ADO. Each selected beneficiary would be provided Subsidy for a good quality hand driven chaff cutter at a cost of 8000. During currunt financial year 500 families would be covered ..
